THIS QUITCLAIM DEED made and dated this 20th day of December, 1994, by and between Double E Land & Cattle Company, a Virginia corporation, hereinafter referred to as Grantor, and Calmes Neck Property Owners Association, a Virginia nonstock corporation, hereinafter referred to as Grantee.

NOW THEREFORE, WITNESSETH: That for and in consideration of the sum of Ten Dollars (\$10.00), cash in hand paid, the Grantor does hereby remise, remit and quitclaim unto the Grantee the following parcels of land situate, lying and being in Chapel Magisterial District, Clarke County, Virginia, to wit:

1) All of its right, title and interest in and to all roads located within the subdivision known as Calmes Neck, and the road leading from Virginia State Route 606 to the Calmes Neck subdivision.

2) All of that certain lot of land located in Chapel Magisterial District, Clarke County, Virginia, designated as Lot 88 of Calmes Neck Estates, as shown on the plat of Calmes Neck Estates recorded in the Clerk's Office of the Circuit Court of Clarke County, Virginia, in Deed Book 58 at Page 506, and being a portion of the same property acquired by Double E Land & Cattle Co. by deed from Clifford H. Brincefield, Widower, et al, dated January 20, 1960 and recorded in the aforesaid Clerk's Office in Deed Book 58 at Page 242.

The Grantor herein does hereby further remise, remit and quitclaim unto the Grantee, all of its rights and privileges under the Protective Covenants applicable to all lots in the subdivision known as Calmes Neck including, but not limited to, the right and privilege to make annual charges to defray the cost of maintaining the common facilities within said subdivision, the right to collect such assessment, and the right to enforce all restrictive covenants applicable to lots within the subdivision.
